**2. Clarifications to Questions asked during pre-bid session.**

**a. Can we be advised if there are any selected sub-contractors for this project?**

There are no selected sub-contractors for this project and contractors can obtain quotes from their preferred contractors. The contractors are required to obtain quotes from reputable sub-contractors who have done similar type of work before and not to obtain quotes from sub-contractors who are not cable of doing this type of work. Contractors will be required to submit names of their preferred sub-contractors for each trade during their tender submission. Contractors are also required to strictly follow the tender drawings and quote for items as specified in the drawings. Should they want to quote for any alternative than this will have to be submitted as a separate submission.

**b. Is there provision for temporary power?**

SPC informed that they will provide provision for temporary power connection to the contractor for use during construction.

**c. Is there provision for water?**

SPC informed that they will provide connection point for water.

**d. Is there provision for toilet facilities?**

SPC informed that they will provide toilet facilities to the contractor.

**e. Is space provided for Contractor's site shed?**

SPC informed that they will provide space for contractor to construct their site shed. Contractors will be required to provide proper area for their workers to have lunch. Contractors will also be required to stay within their designated area and not to move around unnecessary withing the facility.

**f. Will SPC take responsibilities for the valuable items on site?**

It will be the responsibility of the contractor to secure their valuable equipment's.

**g. Will SPC provide space for material storage?**

SPC informed that space will be provided in the front carpark area and also where the new containers have recently been placed.

**h. Will SPC provide space for container storage?**

SPC informed that they will provide space for 1 x 20-foot container should contractor wish to store one.

**i. Noise level during working hours?**

Contractors must note major demolition works must be after hours or during the weekends.

**j. What time slots can the constructors use for construction work?**

The site will be available during normal working hours however should the contractor wish to work after hours, this will be allowed by SPC.

**k. Can the contraction request for site visit anytime before the clarification submission deadline date?**

Yes we can arrange for site visitation. Appreciate if the Contractors could request for site visitation through the procurement email [procurement@spc.int](mailto:procurement@spc.int) a day ahead so that SPC could plan and make arrangement for site visitation.
