- REMOVE ALL EXISTING STEEL FLOORING AND REPLACE WITH NEW 1/4 x 2 x 2 GALVANIZED STEEL TUBE, PROPER LY WELDED TO THE EXISTING STEEL SUPPORT.
- DERUST AND REPAIR AS NEEDED ALL EXISTING STEEL FLOORING, STAIRS, AND RAILINGS SUPPORT AND PAINT IT WITH TWO (2) COAT PRIMER AND TWO (2) COAT FINISHING PAINT.
- Contractor's Responsibility to Provide all Needed materials, tools and equipment needed.
- Demobilization and Final Clean Up.
- > All Works should be properly coordinated with WO Manager or his Designee.
