# 1.2 SPC's procurement activities

#### 1.3 SPC's Request for Quotation (RFQ) Process

At SPC, procurement valued at more than EUR 2,000 and less than or equal to EUR 45,000 requires an evaluation of at least three quotations to determine the offer that provides the best value for money through a Request for Quotation (RFQ) process.

This RFQ sets out SPC's requirements for a project and it asks you, as a bidder, to respond in writing in a prescribed format with pricing and other required information.

Your participation confirms your acceptance of SPC's conditions of participation in the RFQ process.

#### Part 2: INSTRUCTIONS TO BIDDERS

#### 2.1 Background

SPC invites you to submit a quotation to deliver the services as specified in Part 3.

SPC has compiled these instructions to guide prospective bidders and to ensure that all bidders are given equal and fair consideration. Please read the instructions carefully before submitting your bid. For your quotation to be considered, it is important that you provide all the prescribed information by the closing date and in the format specified.

### 2.2 Submission Instructions

You must **submit your quotation and all supporting documents** in English and as an attachment to an email sent to **alifeletis@spc.int** and with the subject line of your email as follows: **Submission PROJECT Governance** – **Vanuatu PSC Surveys**. The email should also be copied to **rfq@spc.int**.

The supporting documents expected in this RFQ are:

- The Conflict-of-Interest Declaration form completed
- Curriculum Vitae, cover letter and quotation.

Your submission must be clear, concise and complete and should only include a quotation and information that is necessary to respond effectively to this RFQ. Please note that you may be marked down or excluded from the procurement exercise if your submission contains any ambiguities or lacks clarity.

Bids will be evaluated on the basis of information received by 11.59pm Fiji Time on 16/02/2023.

#### 2.3 Evaluation & Contract Award

Each quotation validly received will be assessed against the evaluation criteria matrix set out in <u>Part 4</u>. Any changes in the evaluation criteria will result in the RFQ process being re-issued.

SPC may award the contract once it has determined that a bidder has met the prescribed requirements and the bidder's proposal has been determined to be substantially responsive to the RFQ documents, provide the best value for money (highest cumulative score) and best serve the interests of SPC.

In the event of a bid being accepted, procurement will take place under SPC's <u>General Terms and Conditions</u> <u>of Contract</u> and depending on the value or nature of the procurement, the award will be made by issuing a purchase order or a signed and dated contract, or both.

Details will be kept of any communications between SPC and bidders. This assists SPC to ensure transparency of the procurement process. While SPC prefers written communication in the RFQ process, at any point where there is phone call or other conversation, SPC expects to keep a file note of the exchange, with all forms of communication with prospective bidders to be retained as source documents for the procurement of the services.

#### 2.6 Legal and compliance

**Confidentiality:** Unless otherwise agreed by SPC in advance or where the contents of the RFQ are already in the public domain when shared with the bidder, bidders shall at all times treat the contents of the RFQ and any related documents as confidential. SPC will also treat the information it receives from the bidders as confidential.

Conflict of interest: Bidders must take all necessary measures to prevent any situation of conflict of interest. You must notify SPC in writing as soon as possible of any situation that could constitute a conflict of interest during the RFQ process. If you have any familial connection with SPC staff, this must be declared, and approval will then be sought for you to engage in the RFQ process. In support of your response to this RFQ, you must submit to SPC the Conflict-of-Interest Declaration form available on our procurement page website: https://spc.int/procurement.

Breach of this requirement can result in SPC terminating any contract with a successful bidder.

Currency, validity, duties, taxes: Unless specifically otherwise requested, all proposals should be in Vanuatu Vatu and must be net of any direct or indirect taxes and duties, and shall remain valid for 120 days from the closing date. The successful bidder is bound by their proposal for a further 60 days following notification they are the preferred bidder so that the contract may be awarded. No price variation due to escalation, inflation, fluctuation in exchange rates, or any other market factors shall be accepted at any time during this period.

**No offer of contract or invitation to contract:** This RFQ is not an offer to contract or an invitation by SPC to enter into a contract with you.

**Privacy:** The bidder is to comply with the requirements of applicable legislation and regulatory requirements in force for the use of personal data that is disclosed for the purposes of this RFQ. SPC will handle any personal information it receives under the RFQ in line with its <a href="Privacy Policy">Privacy Policy</a>, and the <a href="Guidelines for handling personal information of bidders and grantees.

Warranty, representation, assurance, undertaking: The bidder acknowledges and agrees that no person has any authority to give any warranty, representation, assurance or undertaking on behalf of SPC in connection with any contract which may (or may not) follow on from this RFQ process.

# 2.7 Complaints process

Bidders that consider they were not treated fairly during any SPC procurement process may lodge a protest. The protest should be addressed to <a href="mailto:complaints@spc.int">complaints@spc.int</a>. The bidder must provide the following information: (1) full contact details; (2) details of the relevant procurement; (3) reasons for the protest, including how the alleged behaviour negatively impacted the bidder; (4) copies of any documents supporting grounds for protest; (5) the relief that is sought.

#### Part 3: TERMS OF REFERENCE

#### A. Background/context

Public Service Commission's manage public services in pursuance a professional, ethical and an apolitical arm of government. They establish the governance framework on which public services operate and manage, amongst other functions, the appointment of Director Generals, Ombudsmen and other senior public servants. An effective and efficient Public Service Commission is essential for effective government and a key national institute delivering Just Governance.

Promoting Just, Engaged, Civic-minded and Transparent (PROJECT) Governance is a project funded by USAID and implemented by the Human Rights and Social Development Division of SPC to support and strengthen good governance in Pacific Island Countries' countries.

During PROJECT Governance consultations, the need to strengthen Public Service Commissions was a common theme raised. In response to this, PROJECT Governance undertook an in-country visit to Vanuatu in early December 2022 to consult and confirm Vanuatu's needs.

At the request of the Government of Vanuatu, PROJECT Governance will support the Vanuatu Public Service Commission (OPSC) to address key structural and policy issues in the advancement of a responsive, efficient, ethical and fit-for-purpose Vanuatu public service in pursuit of the Government's, national objectives, sustainable development goals, and the objectives of the 2050 Strategy for the Blue Pacific Continent.

#### B. Purpose, objectives, scope of services

The primary objective of the consultancy is to capture capture stakeholders' perceptions of the public service through surveys that will inform, influence and guide evidence-based PSC decision-making policies and processes. The consultant will work with the Innovation and Policy Development Unit (IPDU) of the Vanuatu Public Service Commission:

- The IPDU will support the consultant in the design and development of three survey questionnaires, training on data collection tools, analysis, and reporting;
- The surveys' goals are to engage senior public servants and the public in charting a way forward for the Public Service looking at current state, including roadblocks, tools, perceptions of what reform is needed. The surveys will set baselines for the IPDU to track progress annually;
- The consultant will work with Director Generals, Directors and ministries' Human Resource
  Managers and the OPSC Human Resource Manages Unit to develop questionnaires to gauge
  perceptions of Public Service on current weaknesses and strengths of public service and to input
  what is needed to improve OPSC efficiency (e.g., improving tools, online access to tools, clearer
  policies, etc.);
- The consultant will work with OPSC Managers, the SPC Statistics for Development Division, and the VBS to design questionnaire to gauge public views on Public Service effectiveness and gaps;
- Should it be required, more support can be drawn in to support the work; and
- The Vanuatu Bureau of Statistics will implement the surveys with cost support.

#### C. Timelines

The work is expected to take 50 working days beginning in late February and ending in May 2023.

#### D. Reporting and contracting arrangements

- The consultant will be directly responsible to OPSC and SPC to provide updates at the start and end of each week on the progress of the work.
- The consultant will be required to work closely with the OPSC, IPDU, the Vanuatu Bureau for Statistics, SPC's Statistics for Development Division, relevant government ministries and public stakeholders, as required.
- OPSC and the IPDU will provide policy and local contextual advice on the design of the surveys, the Vanuatu Bureau of Statistics and SPC's Statistics will provide technical assistance including implementation of the surveys, as required, including coordination with government ministries and public stakeholders.
- Should it be required, more support can be drawn in to support the work.
- The consultant will work in Port Vila from the OPSC who will provide office space.
- Costs for travel within Vanuatu during the consultancy surveys will be borne by OPSC.

## E. Skills and qualifications

- A minimum of 15 years working experience in a Pacific public service in a senior position, including expertise in public sector reform and survey work.
- A minimum of 10 years working experience in the public service or private sector would be an advantage, especially in Vanuatu or other countries in the Melanesian region.
- The consultant would have to be Vanuatu-based and be culturally aware and respectful of ni-Vanuatu culture.
- The minimum qualification would be a post-graduate qualification in the field relevant to the public service.

#### F. Scope of Bid Price and Schedule of Payments

- The contract price will be based on lump sum payments tied to the 8 milestones set out below.
- The cost components must be inclusive of professional fees the consultant's local living costs.
- The terms of payment shall be in accordance with the provisions of Article 10 of SPC's General Conditions.
