Regulations to amend Schedule 3 of the Marine Resources (Longline Fishery) Regulations 2008

1. <u>Title and commencement</u> - (1) These regulations may be cited as the Marine Resources (Longline Fishery) Amendment Regulations 2010, and shall be read together with and deemed part of Marine Resources (Longline Fishery) Regulations 2008 (hereinafter referred to as "the principal Regulations").

(2) These regulations shall come into force on the day they are assented to by the Queen's Representative.

2. <u>Schedule Amended</u> - Schedule 3 of the principal Regulations is hereby amended by deleting "\$2500", "Under 18 Metres", and "18 metres and over", in the table in paragraph 4; and substituting "\$2000", "Under 20 Metres", and "20 metres and over" respectively.
