PREFACE

The Fiji Classification of Individual Consumption According to Purpose (FCOICOP) 2010 has been derived from the United Nations (UN) Individual Consumption According to Purpose which is a Classification of Expenditure According to Purpose. Necessary modifications to meet national requirements have been made. This has been done without disturbing the framework of the UNs COICOP so that international comparisons can be made. This is the first such classification for Fiji and shows household consumption on food, clothing, housing, health and education, all of which are important indicators of national welfare.

This publication consists of three parts. Part I provides information on FCOICOP. Part II, Chapter 1 contains the structure at one- and two-digit levels. Breakdown at these aggregated levels is important because of its use in national accounts statistics. Chapter 2 contains the detailed classification. Part III contains the detailed corresponding tables between FCOICOP 2010 and the classification that was followed for the 2002 household expenditure survey.

The Economic Statistics Division of the Fiji Islands Bureau of Statistics put in a lot of hard work in producing the FCOICOP.

The Division came up with the draft Fiji Classification of Individual Consumption According to Purpose 2009 for comments. Comments received helped refine the classification.

The classification was then put to test when the Household Survey Division embarked on household expenditure survey for 2008.

The final product is the Fiji Classification of Individual Consumption According to Purpose 2010 and I am grateful to all those who helped in any way.

PART I

1 Historical background

The Fiji Classification of Individual Consumption According to Purpose (FCOICOP) 2010 is the first for Fiji and replaces the expenditure classification used earlier by the Fiji Island Bureau of Statistics. Part III of this publication provides the concordance between the FCOICOP 2010 and the classification used earlier.

2 FCOICOP 2010

FCOICOP 2010 is a classification of expenditure according to purpose. The purposes defined in the FCOICOP 2010 are based on the classifications of consumer expenditure and the FCOICOP 2010 Divisions 1 through 12 identify the purposes for which these expenditures are made. All consumption expenditures by households are defined as individual.

3 Units of classification

The units of classification are expenditures for the acquisition of consumption goods and services. The basic data comes from one of the following sources:

- Household expenditure surveys
- Statistics on retail sales
- Commodity flow estimates which involve allocating the total supply of goods and services to intermediate and final uses.

The important point to note is that the units of classification are expenditures on specific goods and services – they are not expenditures on purpose as such. Divisions 01 to 12 of FCOICOP 2010 convert these basic statistics into a purpose classification by grouping together the various goods and services that are deemed to fulfil a particular purpose, such as nourishing the body, preventing and curing illness, acquiring knowledge, travelling from one place to another etc.

4 Multi-purpose goods and services

The majority of goods and services can be assigned to one purpose, but some can be assigned to more than one purpose eg motor fuel which can be assigned to:

- power vehicles classified as transport
- power vehicles classified as recreational

The general rule is to assign multi-purpose goods and services to the division that represents the predominant purpose. Hence, in Fiji's case, motor fuel would be shown under Transport.

5 Mixed-purpose goods and services

Single outlays sometimes comprise a bundle of goods and services that serve two or more different purposes eg the purchase of an all inclusive package tour will include payments for transport, accommodation and catering services. Outlays covering two or more purposes are dealt with on a case-by-case basis with the aim of obtaining a purpose breakdown that is as precise as possible and consistent with practical considerations of data availability.

6 Type of product

FCOICOP 2010 classes are divided into “services” (S), “non-durables” (ND), “semi-durables” (SD) and “durables” (D). The distinction between non-durable and durable goods is based on whether the goods can be used only once or repeatedly or continuously over a period of more than a year. Semi durable goods differ from durable goods in that their lifetime of use, though more than a year, is usually shorter and their purchasers’ price is substantially lower.

The classification by type of product provides for other analytical applications eg it is sometimes useful to estimate the stock of capital goods held by households - goods in FCOICOP 2010 classes that are identified as durables provide the basic element for such estimates.

7 Structure of FCOICOP 2010

Consumer expenditure are subdivided in a hierarchical, five-level structure of mutually exclusive categories, facilitating data collection, presentation and analysis at detailed levels of the economy in an internationally comparable, standardized way. The categories at the highest level are called divisions, which are numerically coded categories intended to facilitate economic analysis. The divisions subdivide the entire spectrum of consumer expenditure into two-digit broad groupings, such as Food and non-alcoholic beverages (01), Alcoholic beverages, tobacco and narcotics (02), Clothing and footwear (03), Housing, water, electricity, gas and other fuels (03) et al. The classification is then organized into successively more detailed categories, which are: three-digit groups; four-digit classes, seven-digit sub-classes and, at the greatest level of detail, nine-digit items.

8 Uses of FCOICOP 2010

Apart from being an integral part of the System of National Accounts, FCOICOP 2010 is also used for the:

- Household expenditure survey
- Consumer price indices
- International comparison of the gross domestic product (GDP)

9 Application of FCOICOP 2010

A General remarks

FCOICOP 2010 reflects expenditures by households that is of general interest and amenable to a wide variety of analytical applications. For example it shows the household expenditure on food, clothing, housing, health and education, all of which are important indicators of national welfare. It provides a framework for the international comparison of national statistics since it has adopted the same general principles and definitions of the COICOP.

B Use of COICOP in establishing FCOICOP 2010

- FCOICOP 2010 is based on COICOP.
- There are instances when categories are either expanded or contracted, depending on the consumer spending in Fiji. If a particular class is of importance, the relevant classification is expanded. If some other class does not exist or is unimportant the relevant part of the classification has been contracted.
- FCOICOP 2010 can be easily converted to COICOP since the categories at the sub-class level of FCOICOP 2010 are subdivisions of the most detailed level of COICOP, i.e. 4-digit level known as class.

C Use of different levels of the classification

By providing for varied levels of classification like divisions, groups, classes, sub-classes and items, FCOICOP 2010 furnishes a framework for comparable classifications of data at different levels of detail.

10 Concordance

Part III gives the co-relation between the FCOICOP 2010 and the previous expenditure classification used at the most detailed level.

11 Reviews

Experience in the use of classifications reveal the need for a periodic review of the structure and definition of its categories and underlying principals since changes take place in the consumption pattern of households in Fiji. It also reveals aspects that should be amplified, clarified or improved in other ways whilst maintaining as much comparability between the revised and the preceding version.
