The Palau education statistics covers all educational institution throughout Palau. Data are compiled by the Ministry of Education but not published by them. The Statistics Office collects the raw data in mid January each year from the Ministry of Education and publishes them in the Annual Statistical Yearbook. Type of information collected are numbers of enrollment beginning in preschool through the one local college. Pre-school information is limited to total enrollment, number of schools and classrooms, teachers and assistant teachers. Elementary and secondary school information are more detail. Types of information provided are individual school enrollment by sex and grade, number of teachers to include all school support personnel. Information provided for preschoolers, elementary and secondary schools are presented by individual institutions, for both private and public schools. The Palau Community College information provided are similar to those at the lower level with additional details. Additional information for the college students includes area and level of study. Finally 2000 Population Census tables also give aggregates of enrollment by level and education attainment.
