## Introduction to the Country Profile

SPC country profiles document the nature and extent of the organisation's services to individual members.

This country profile presents basic country facts and a synopsis of Vanuatu's development background and a narrative summary of the Secretariat's assistance during 2008. Annexes include specific SPC country activities and human resource development activities.

## Vanuatu Development Background

Vanuatu is a democratic republic with a 52-member Parliament elected every 4 years. Independence was attained in 1980 after some 74 years of joint rule by Britain and France. The islands were then known as the New Hebrides. The executive consists of a Council of Ministers headed by the Prime Minister who is elected by Parliament from among its members. The President is elected by Parliament and the National Council of Chiefs for a period of five years.



The country has a dualistic economy, with a large smallholder subsistence agricultural sector and a small monetised sector. The monetised sector consist of plantations, ranches and associated trading, manufacturing, banking and shipping services, as well as the country's tourist industry. Copra is the most important cash economic activity in the rural sector. At present, about 69,000 hectares of land are under coconut plantation, producing 50,000 tons of copra a year. Nearly all exports are primary goods (coconut products, beef, cocoa, coffee and timber).

The introduction of commercial laws in the early 1970s added a new dimension to the economy; it led to the development of an off-shore finance and banking centre, and a rapid expansion in the number of support organisations and professionals in Port Vila. The Finance Centre contributes considerably to Government revenue through the payment of business licence fees, insurance, banking and trust company licences, annual registration fees for all companies, stamp duties and other smaller fees. It is also a significant earner of foreign exchange through capital transfers, professional fees, interest etc.

The Government earns substantial revenue from turnover taxes on hotels, licensed premises, and casinos. Vanuatu has also enacted legislation to allow all forms of betting

(under strict controls). In recent years, Vanuatu has realised impressive economic growth, which is widely attributed to stable governments and substantial reforms and restructuring that have occurred since 1997.

Despite significant investments in the education and health sectors, progress in these key areas is generally considered slow. Transport services continue to be constrained by lack of adequate infrastructure and maintenance problems.

The country is experiencing high general population growth rates and even higher urban growth in Port Vila and Luganville. Income per person in real terms has declined by 18% between 1994 and 2003 before rising slightly since 2004. Unemployment appears to be increasing, especially amongst young people. This is leading to increasing social concerns as well as increasing levels of hardship and poverty. The recent strong economic growth, however, does seem to make a positive impact.

Vanuatu is still largely an agriculture-based economy with copra, cocoa, kava and cattle continuing to dominate the sector. Since 2003, the agriculture sector has grown at an annual rate of 3.3 percent compared to 2.8 percent growth for the economy and an average population growth rate of 2.6 percent per annum.

Fisheries are said to be not properly exploited. Reef fisheries are over-fished in some areas, notably in around the island of Efate, but are generally under-exploited near the outer islands. The deep water snapper resource has the potential for some further exploitation but there appear to be definite limits. Improvements in catching, handling and marketing systems and commercialisation of the domestic fishing industry are needed; however, overall Vanuatu's fisheries are probably not sufficient to supply a larger proportion of the protein needs of a rapidly growing population.

Vanuatu possesses soils and climate that are conducive to timber production. The challenges continue to include ensuring replanting of trees at a rate at least equal to the volume being harvested; to foster utilisation of additional species; and to develop additional value-added processing. Vanuatu faces a natural constraint to large increases in production of forestry products, as even though some 36% of the country is forested, a large part of this is unsuitable for commercial logging due to the poor quality of timber and inaccessibility to sites.

Vanuatu has one of the most conducive environments in the world for raising beef cattle. Domestically the production of beef, pork, poultry and sheep/goat for local consumption forms an essential part of the rural economy. Improvement in the capacity of farmers and their communities to produce, process and sell these animals and products will have a positive effect on rural farmers' incomes, and offer opportunities to promote rural enterprises such as butcheries. Improvements in domestic livestock production and processing would also improve the level of food security and safety in rural communities, while promoting the substitution of local meat for imported products.

Life expectancy is currently 69 years for females and 66 for males (1999 Census). There has been progressive improvement in key health indicators over the years. Under 5 mortality has reduced from 58 per 1,000 live births in 1989 to 33 in 1999 and similarly infant mortality has declined from 45 per 1,000 live births in 1989 to 25 in 2007 (estimates).

In the medium term, the education sector is concentrating on the Millennium Development Goals of achieving universal primary education and gender equality in education. Access to secondary education remains very low, compared to many other Pacific Island countries. Vanuatu's challenges in the education sector are unique: the country has more than 105 languages and three official languages (Bislama, English and French); schools are scattered over more than 60 islands and often in remote locations; a high rate of population growth, and rapid urban drift.

Vanuatu is the only Pacific recipient of the US Millennium Challenge Account. The five-year Compact program addresses the country's poor transportation infrastructure. Consisting of eleven

infrastructure projects—including roads, wharfs, an airstrip and warehouses—the program aims to benefit poor, rural agricultural producers and providers of tourist related goods and services by reducing transportation costs and improving the reliability of access to transportation services. This MCC program is expected to have a transformative impact on Vanuatu's economic development by increasing average income per capita by 15% within 5 years and directly impacting the lives of more than 65,000 poor, rural inhabitants—almost a third of the entire population.

## **Summary of SPC Assistance to Vanuatu 2008**

This section provides an overview of SPC assistance to Vanuatu by division and programme for 2008. A more detailed listing of activities can be found in Annex 1.

### *Land Resources*

The Land Resources Division, through DSAP, carried out on-farm trials on Efate and Santo using leguminous crops *Gliricidia* and *Mucuna* as short fallow cover crops demonstrated good soil fertility regeneration. *Mucuna* has been trialled in two research stations with good results in soil fertility improvement and crop productivity increases. Support to a rural-based community-owned joinery shop which allows for an income generating activity for the community. Technical assistance has also been provided to enable market access for Tahitian lime and other citrus produce to New Zealand, papaya to Australia, and Vanuatu beef to Nauru.

### *Marine Resources*

During 2008, SPC's Marine Resources Division has helped Vanuatu fisheries set up Live Reef Fisheries database; reviewed aquaculture prospects for Vanuatu and published Vanuatu Aquaculture Action Plan; started ACIAR mini-project in Vanuatu on culturing clownfish for the marine aquarium trade and presented Vanuatu National Tuna Fisheries Assessment report and provided scientific support to Vanuatu/FFA Ecosystem Approach to Fisheries workshop. The division has also assisted with the conduct of the reef invertebrate population survey at Epi, as well as the reef fish population survey at Epi. The Regional Maritime programme ran follow-up ISPS and STCW audits, security guard training course, port management and administration assistance and basic ISPS Code course.

### *Social Resources*

Through its Public Health programme, SPC assisted Vanuatu in the development of GFATM R7 submission for HIV and establishment of seafarers' drop-in-centre. The conduct of Infection Control (PRIPPP) training and support for implementation of Infection control measures to minimize risks to health works, animal laboratory workers and animal health/quarantine workers was carried out. Procurement of antiviral and supplies for Rapid Containment and orientation to planning process and planned testing exercises processes was also provided by SPC. Through the Global Grant, SPC assisted Vanuatu with the procurement of Health Products and Health Equipment and assisted in grant preparation and successfully concluded grant negotiations for two round seven HIV and TB proposals submitted to the global Fund with phase 1, 2 year combined value of \$16.34 Million. Grants commenced 1<sup>st</sup> July 2008.

SPC's Human Development Programme supported the book launch & community reporting back on matrilineal land tenure report to Vanuatu Cultural Centre and conducted business enterprise trainings in March and May 2008. SPC's Statistics and Demography Section assisted in the preparation of 2009 Census Plan/Budget and census cartography.

*Other Assistance and human resource development highlights*

During 2008, one hundred and eleven persons from Vanuatu participated in SPC training activities, organised by SPC's Land Resources, Social Resources (public health, statistics and demography, media centre, community development, RRRT), and Marine Resources (maritime, oceanic and coastal fisheries) Divisions.
