1. The theme of the conference and Ministerial meeting is the **economic empowerment of Pacific women** with the objective to identify strategic measures and make recommendations to support the economic empowerment and wellbeing of Pacific women. The theme encompasses employment in the formal and informal sectors; unpaid care work; social protection; impacts of macroeconomic policies; budgeting and financing for gender equality and women's human rights. The purpose of the Conference is to share experience, reflect on progress and challenges, and identify strategic and practical measures to accelerate progress towards women's economic empowerment at national and regional levels. The conference is an opportunity to consider how the revised Pacific Platform for Action on Gender Equality and Women's Human Rights (PPA) and the proposed strategic objectives namely research and data, gender mainstreaming processes, partnerships, sustained investments, and accountability could accelerate efforts to promote gender equality, including the economic empowerment of Pacific women.

2. **The 13<sup>th</sup> triennial conference of Pacific Women** will be held on 2, 3 and 4 of October 2017. The conference is a unique space to share and learn from countries' and territories' experience to support women's economic empowerment and wellbeing and strengthen partnerships between representatives of government institutions, civil society organisations, academics, private sector, and development partners.

3. **The 6<sup>th</sup> Meeting of Pacific Ministers for Women** will start on the evening of the 4<sup>th</sup> of October and conclude on 5<sup>th</sup> of October 2017. The Ministerial meeting is a continuation of the Conference where discussion on government positions and agreement on the Conference's recommendations and strategic actions will take place. Ministers will discuss the structural barriers they face within government to progress women's economic empowerment and identify appropriate strategic interventions to address these.

4. The Ministerial meeting also offers the opportunity to obtain regional agreement and adoption of the revised Pacific Platform for Action for Gender Equality and Women's Human rights, which proposes measures to accelerate regional and national commitments to gender equality including the Agenda 2030 for Sustainable Development and the Pacific Leaders Gender Equality Declaration.

#### **Negotiation of the recommendations of the outcomes document**

5. During the Conference, delegates will negotiate the Outcomes Document, focusing on strategic and practical measures to accelerate progress towards women's economic empowerment, among other issues, which will be officially endorsed at the subsequent Minister's meeting. The negotiation process will establish regional agreement and a shared platform on key gender equality issues to be presented across other meetings of Ministers and senior government officials and associated processes, (such as the Forum Economic Ministers Meeting), as well as global meetings and negotiations.

#### **The proposed organisation of work of the Conference**

6. The two and a half day Conference of Pacific Women includes a mix of interactive dialogues, roundtable discussions, parallel sessions, and the negotiation of the recommendations of the outcomes document.

7. The one and half day Ministerial meeting begins with a high level dialogue comprising Pacific Island leaders who will share their views how women's economic empowerment and gender equality builds resilience and achieve sustainable development for Pacific communities.

Women’s economic empowerment is more than increasing opportunities to work and employment, although this is an important component. Women face structural, social and cultural obstacles that deprive them of equal opportunities to employment and income generation including gender roles, norms and stereotypes. Obstacles are reinforced implicitly or explicitly in legislation, regulations and policies, and also in the enforcement of these legislations and policies.

During this session, participants will reflect on issues hindering the economic empowerment of women; such as the burden of unpaid care work, limited social protection, and the adverse impacts of macroeconomic policies and workplace environments; as well as learning from experiences across the region towards removing and eliminating these obstacles.

**Session Outcome:** *The discussion of the impacts of the social and institutional context on women’s economic empowerment will identify a range of concrete measures to implement at the national and the regional level to shape social and economic policies that work for women.*

At the 5<sup>th</sup> Meeting of the Ministers for Women held in Rarotonga, Cook Islands in 2013, Ministers recommended the review of the Revised Pacific Platform for Action for the Advancement of Women and Gender Equality (RPPA). An independent review of the RPPA conducted in 2014/2015 recommended SPC, in partnership with Pacific Islands Forum Secretariat (PIFS) and with input from all PICTs, should coordinate the development of a regional platform or plan of action for gender equality and the advancement of women. The ‘new PPA’ has been designed as an instrument to accelerate progress towards gender equality in the region, in particular commitments made through the Pacific Leaders Gender Equality Declaration, and the Sustainable Development Goal 5 on Gender Equality and Women’s Empowerment, and national gender policies. The 13<sup>th</sup> Triennial Conference of Pacific Women presents the new PPA to Ministers for women for endorsement.
