

SAY NO TO GROUPER, JANUARY 1 TO APRIL 30

IT'S THE LAW

Chuuk State has banned the fishing, sale and export of grouper during their peak breeding months, January 1 to April 30, to help ensure sustainable catches today and tomorrow.

The ban is needed because grouper is an important commercial fish for export markets and is vulnerable to overfishing.

Grouper are at risk because they gather in large numbers and in the same places and times every year to breed. That fact makes it easy to fish out breeding stock.

The grouper ban is intended to ensure grouper fish are able to breed each year, so we catch more later. The goal is bigger better catches today and tomorrow

For fishers, fish sellers and exporters, violations may result in confiscations and fines









>>>>> WHAT ARE THE BENEFITS OF THIS BAN? MORE FOOD, MORE MONEY

The ban is about getting more food on our plates, and more And even if you don't rely on grouper yourself, these money in our pockets. It's important to acknowledge that fishers are having a harder time making a living in Chuuk as fishing grounds become more depleted, particularly near population centers.

Fishers are spending longer hours in the water, catching less, and making less money than before. This ban will help increase fish stocks of one of the most valuable commercial. The future of fishing in Chuuk will be about ensuring fishers fish, which means our fishers can in turn earn more money and better provide for their families. That's the benefit of the ban.

fish still matter to you. Grouper are on top of our coastal fisheries food chain. So just like sharks, they play an important role in keeping our fishing grounds healthy and providing lots of other fish you might depend on. So if we lose them, it will effect other fish we like to eat and the overall health of our fishing grounds.

get the maximum amount of fish from our fishing grounds and can make more money on each fish. That will mean fishing smarter, and for grouper, that means making sure they breed

WHAT IF I CATCH ONE BY MISTAKE?

If you accidentally catch a grouper, you should let it go. Because that fish could bring you far more fish in years to come, if it gets a chance to breed before you eat it. The reason these fish are declining so rapidly is because fishers target their breeding sites. The good news is that fishers are well aware of where the fish breed and can easily avoid the channels where they typically are breeding.

In other words, fishing in a breeding site is not an accident. So avoid those sites and fishing around those sites.

And it's important to note, anyone attempting to sell accidental catches of grouper can be prosecuted.
