FISHERIES AND RELATED LEGISLATION

OF FFA MEMBER COUNTRIES

Access to up to date legislation is vital for lawyers and fisheries managers in FFA member countries. Similarly, if FFA is to provide a prompt response to requests for legal assistance from member countries it is essential that we have complete and up to date holdings of all legislative materials relating to fisheries matters.

In the FFA Corporate Plan 1990 - 1999, member countries recommended that FFA establish a computer database of regional fisheries legislation. Although various factors have made it impossible to achieve this objective to date, considerable efforts have been made by FFA's legal services and information divisions to collect and index copies of all relevant legislation from member countries. It is hoped that it will soon be possible to collate this information for publication as a compendium of regional fisheries legislation.

In the meantime it is hoped that this comprehensive index of the available legislation will be of assistance to member countries. It is envisaged that only will it enable non-lawyers to find out what legislation is current in their own countries, but also it will allow lawyers to readily ascertain what legislation applies in other countries in the region. Except where otherwise indicated, the FFA Library holds copies of all the materials in this index.

The index will be regularly updated. We would therefore be grateful of any errors or omissions from this index can be made known to FFA as soon as possible.

AUSTRALIA

<u>Note</u>: Australia has recently made very substantial changes to its fisheries legislation. The new Fisheries Management Act came into force in February 1992. With the assistance of the Office of International Law of the Attorney-General's Department, the Agency has at long last been able to update its holdings of Australian Fisheries and Offshore legislation.

An index to the legislation appears below. This index shows the new legislation of 1991, relevant offshore and other legislation still in force, and the fisheries legislation as is stood before the 1991 legislation came into force. The references in the latter table are to the principal Acts and amendments thereto since each Act was passed or alternatively since the last reprint was issued of a particular Act.
